#### **7. Revision of rules**

The President informed the meeting she was currently in the process of redrafting the Guild rules. She suggested that anyone who wished to input into the process give her their email address. J A Agg suggested it could be easier to send an email to everyone. F W R Manners commented that this would result in the entirety of the Guild's email inboxes being spammed as people gave their opinion. P J Earis suggested sending it to the global list to avoid this. It was felt that a simpler option was simply to give the President the email addresses and a list was sent round to allow people to submit their email.

#### **8. Cambridge towers**

The Master reported that no maintenance had been carried out, though it would be good to check the tower at StAG before the peal on the 22<sup>nd</sup>. The Master also reported that relations with StAG were better than in the past and that the Guild are able to ring at the church whenever they request to, so long as no other event was happening at the church. The meeting was informed as to the situation at Bene't's where a minor crack had been noticed in the church tower. The church had hired a consultant and no further action is to be taken. There has been minor work at Bene't's the rope on the tenor has been replaced and the Master remarked that the rope on the third will likely need replacing soon as well, saying it would be useful to get some more stays as well.

The President recapped the progress of the St John's Project, informing the meeting that the project had been under consultation with Senior Members of the College and so was now in the public domain. The matter had been discussed by the Governing Body, though no vote had been taken. It is clear that St John's are unwilling to fund the project, so if the College does approve the project in principle it is likely that the Guild will need to launch a major fundraising effort. The President will keep the Guild informed on progress.
